As per the UCI regulations, it is the Athlete's responsibility to attend their scheduled Classification appointment. No requests for changes to Classification days will be accepted.

Athletes who do not attend their scheduled Classification appointment without prior notification (minimum 24h in advance) may be fined 200 CHF and/or designated as Classification Not Completed (CNC) in accordance with Article 16.4.029. Athletes designated as CNC may not compete until Athlete Evaluation is completed.

All Athletes must provide an MDF and medical information prior to Classification. Athletes who do not provide medical information will be removed from the Classification schedule and may not compete until Athlete Evaluation is completed.

Athletes must arrive at the Classification venue at least 15 minutes ahead of their scheduled evaluation session. Athletes may be accompanied by a representative. If the Athlete and representative do not speak English, they must be accompanied by a translator which is the responsibility of the National Federation. Athletes under 18 years of age must be accompanied by one representative.
